SUBJECT: Open Outcry Trading of Hard Red Spring Wheat Options

Effective Monday, February 9, 2009, open outcry trading of MGEX Hard Red Spring Wheat (HRSW) options contracts will occur in the new Exchange Room in Suite 880 of the MGEX North Building. The designated area for trading options includes any cubicle and the surrounding common areas in Suite 880 from which a Member can effectively communicate with a Market Observer. As a reminder in accordance with MGEX Rules, Regulations and Resolutions and Interpretations all Members participating in the open outcry options market in the designated area must promptly notify the Market Observer of the all trades, bids and offers for any HRSW options contract.
